

The purpose of this letter is to notify you that the Village of Elmwood Park, in conjunction with the Illinois Department of Transportation and Cook County Department of Transportation and Highways are currently in the preliminary phases of a Planning and Environmental Linkages (PEL) and Phase I Preliminary Engineering Study for the improvement of Grand Avenue at the Metra/Canadian Pacific Railroad.

It is the policy of the Illinois Department of Transportation and the Village of Elmwood Park to provide the public an opportunity to become acquainted with highway improvement proposals of potential concern to them and to provide an opportunity for their input.

The Grand Avenue rail crossing ranks in the top few most dangerous crossings in Illinois. Safety is the top priority. In addition to improving safety, project improvements are expected to increase mobility throughout the region. The proposed improvement alternatives being evaluated include, for example, a new grade separation where Grand Avenue crosses the Metra train tracks.
